#### A. Retaining Wall Project Engineer Proposals:

Based on Miller Dodson Reserve Study recommendation, the Marksburg Court retaining wall needs to be replaced in the spring of 2012. Because this is a complex construction project, it is recommended that an engineering firm complete the design, bidding, and construction oversight of the retaining wall project. The Board had requested BEC give a rough estimate for the total cost of replacing the wall. BEC stated it would be approximately \$43,000.00 and approximately \$8,000.00 of that cost will be for the design, bidding, contract administration and construction observation services. Management obtained two other proposals from Engineering and Technical Consultants (ETC) and Thomas Downey, LTD (TDL). Vanguard has worked with all three companies and they all do good work. The segmental block wall should last for a very long time. The current wood wall is starting to lean. The Association currently has \$43,000.00 in the Townhouse Reserve Money Market account so we won't have to pull funds from CD's and the actual cost may be less.

Motion: That we approve BEC's engineer proposal and move ahead with the project. Martin/Brooks Vote: Unanimous

### **B.** Grounds Maintenance:

Management has spoken with MainScapes and they are aware of the landscaping issues. MainScapes would like to try an entire new crew. The Board would like Gary Saylor to come and inspect his crews after the work is completed. The Board again discussed their disappointment with the entrance plantings that MainScapes did and would like to consider using Potomac Garden Center for future plantings.
