### **Street Parking on County Streets**

It has been brought to the Boards attention that many residents are parking their vehicles on county owned streets. Please be advised that ALL Single Family homes are located on County streets. Listed below are a few of the laws pertaining to street parking.

### Sec, 31-14. Parking of commercial vehicles or buses abutting residences, schools, etc.

It shall be unlawful to park any commercial vehicle or bus on that side of any public road abutting any private residence, apartment house, church, school, hospital or playground except when such vehicle is actually engaged in loading or unloading passengers, merchandise or materials or when used by the owner or operator actively engaged in work on the premises of the residence.

### Sec. 31-15. Repairing or leaving vehicles on streets for repairs.



It shall be unlawful for any person, business or corporation to perform service or repairs on a vehicles parked on a public street within the county.

### Sec. 31-7. Parking of unregistered motor vehicles or trailers.

It shall be unlawful to park any unregistered motor vehicle or trailer upon the highways, roads, streets or other public property in the county at any time.

### Sec. 31-8. Parking vehicles; impeding traffic, threatening public safety.

No vehicles shall be stopped, standing or parked upon any road, highway, alley or public parking facility of the county so as to impede the movement of traffic or constitute a threat to public safety.

#### Sec. 31-9. Impounding illegally parked vehicles, impeding traffic, etc.

Your vehicle will be towed if:

- 1. You are parked within fifteen (15) feet of a fire hydrant.
- Within twenty (20) feet of any crosswalk whether at an intersection or not, when such crosswalk is marked off by painted 2. lines.
- 3. With one (1) or more of the side wheels more than twelve (12) inches from the curb.
- 4. In a direction other than the flow of traffic.

### Sec. 31-20. Parking prohibited, specifically.

Except when necessary to avoid conflict with other traffic or in compliance with the law or the directions of a police officer or official traffic-control device, no person shall:

- 1. Park on a sidewalk
- Park within an intersection. 2.

# **Motor Scooters**

Many self-propelled vehicles are appearing on the public and private streets and sidewalks within the Kingsview Ridge community. The Maryland Motor Vehicle Laws prohibit the use of certain non-registered motorized vehicles on streets and sidewalks, so they cannot be lawfully driven on public roads by anyone.

Since there are a variety of these types of vehicles, the County Police has provided the following information to clarify what types of vehicles are legal to operate and what their restrictions are for safe operation under the Maryland Motor Vehicle Law.

Motor Scooters (larger vehicles such as Vespas) do not need to be registered. To operate a motor scooter on the street, the operator must be at least 16 years of age and possess a valid Moped Operator's Permit or Driver's License. These vehicles may not be operated on a sidewalk. You may not operate these on a roadway where the speed limit is over 50 mph.

Mopeds and motorized bicycles are human-powered bicycle type vehicles that have a motor assist. These vehicles do not need to be registered. However, to be operated on a public street, the operator must at at least 16 years of age and possess a valid Moped Operator's Permit or Driver's License. These vehicles may not be operated on sidewalks or roadways where the speed limit is over 50 mph.

Mopeds and motor scooters differ from other self-propelled vehicles under Maryland law.

Self-propelled motor vehicles include off-road vehicles such as ATV's, off-road motorcycles, electric and gas powered stand-up scooters, motorized skate boards, mini-bikes and any self-propelled object (e.g. motorized skateboard) that is not a Moped or Motor Scooter by

definition. These vehicles do not meet the safety equipment requirements for registration, so they cannot be registered and they cannot be lawfully driven on the road or highways by anyone, licensed or not. Also, they cannot be operated on the sidewalk. They can only be operated on private property with written permission from the owner or tenant of property.

Parents may have purchased these types of vehicles for their children not knowing the Maryland Motor Vehicle laws. Operating these vehicles, many of which are capable of reaching speeds of over 30 mph, may represent a danger to pedestrians, motorists and their operators. Such small motorized vehicles often may not be seen by cars and trucks. Some of their operators, because of age, have no knowledge of the rules of the road, and pedestrians are often unaware of their presence on sidewalks.

The County Police are compelled to strictly enforce Maryland law as it applies to these various vehicles. The Police WILL charge operators and parents, who allow the operation of these vehicles by minors, with the appropriate sections of the Maryland Motor Vehicle Laws. Charges under these sections can result in FINES OF UP TO \$900.00.

# Trash Disposal

Trash removal is provided twice weekly on Monday and Thursday by Waste Management. DO NOT PLACE YOUR TRASH OUTSIDE ANY EARLIER THAN 6:00 P.M. THE NIGHT PRIOR. DO NOT PLACE YOUR TRASH OUT IF YOUR TRASH PICK-UP FALLS ON A HOLIDAY AS IT WILL NOT BE PICKED UP UNTIL YOUR NEXT SCHEDULED PICK-UP.

All containers for the storage of trash or garbage must be rigid containers of metal or plastic, having tight-fitting, overlapping lids, with a capacity of not less than fifteen (15) and not exceeding thirty-two (32) gallons according to county Code Section 48-24. Trash cans are to be stored out of sight. Items such as exercise equipment, furniture, screen doors etc. are NOT considered household trash and must be disposed of at the Shady Grove Transfer Station off of Shady Grove Road. Regular operating hours are Mon-Fri 7:30 a.m. to 8:00 p.m., Sat 7:30 a.m.-5:00 p.m. Household hazardous waster receiving hours are Thursday-Friday 1:00 p.m.-5:00 p.m., Saturday 8:30 a.m.-5:00 p.m. and Sunday 9:00 a.m.-5:00 p.m. Homeowners are responsible to have these items removed from the community. When items are left out, the Association MUST pay to have them removed from the community which

Montgomery County WILL collect unwanted scrap metal items free of charge. Improper trash disposal can create unclean and potentially unsanitary conditions. Items such as household products harms the environment as well as human health. For more information call 240-777-6400.



will cause the Association fees to increase!

# Recycling Do's and Dont's

Recycling is provided on Wednesday. Instead of putting hazardous materials in the garbage or pouring them down the drain, take them to the County's conveniently located collection site free of charge. Paper must be placed in paper bags or boxes, NOT plastic bags while yard waste must be placed in the appropriate paper bag.

The items listed below are recyclable, however they must be taken to the Shady Grove Solid Waste Transfer Station. DO NOT PUT THESE ITEMS OUT WITH YOUR RECYCLING.

- ➤ Herbicides
- Other pesticides
- ➤ Fertilizers w/herbicides
- > Paint thinners and solvents
- > Swimming pool chemicals
- ➤ Unwanted fuels
- Mercury containing items, thermostats & thermometers

- > Photographic Material
- Brake fluid and Antifreeze
- > Car batteries
- > Oil-based paints
- > Ratteries

### Pet Etiquette



Pet owners must be reminded to walk your pets away from your neighbors' homes. All

dogs, except a service animal is at large if it is outside the owner's premises and not leashed unless it is a dog exercise area designated by the Maryland National Capital Park and Planning Commission or unless the dog is participating in a qualified activity. The common area of a homeowner's association, condominium or cooperative is not the owner's premises. Penalty for Violation: \$500

An owner must not allow an animal to damage or defecate on property outside of the owner's property. An animal may defecate on public property or the common area of property in which the owner shares an interest if the owner immediately removes and disposes of the feces by a sanitary method approved by the Director. Feces may be picked up in a plastic bag. If this bag is placed inside another plastic bag, it may be put out for disposal in your normal household trash.

Complaints may be referred to the Montgomery County Department of Animal Control at 240-773-5960. All dogs and cats 4 months of age or older must have a current rabies vaccination and a County license. A rabies tag from your vet is NOT a County license, it must be purchased separately; penalties are between \$100.00 and \$500.00.

Penalty for violation - \$100

An owner must not allow an animal to enter private property without the property owner's permission. Penalty for violation - \$100

An owner must not allow an animal to cause noise that is loud enough and persistent enough to disturb another person's quiet enjoyment.

Penalty for violation - \$100

# Home Maintenance

Most often, homeowners neglect to properly paint the exterior of their homes. Regular painting is not always the answer. Without proper preparation, (scraping, priming, painting alone will not be sufficient; the paint will begin to peel in no time. Fill depressions or washed out areas

A bi-annual maintenance check should flows away from the house. be performed on your home. You should check for other problems that may worsen or create additional headaches for you if left unattended. Items such as:

#### Roof and Gutters:

Always check for missing or damaged shingles, clogged gutters, roof protrusions, (vents, skylights, etc.) to ensure they are sealed, check the chimney for loose mortar. Chimneys

should be cleaned at least every other year to ensure that all ventilation is open and properly functioning.

### Walls, Windows & Doors:

Look for blistered or peeling paint, loose caulking) of the surfaces to be painted, or cracked caulking, loose siding, loose mortar. Check window weatherstripping. around foundation, make sure drainage

### Plumbing:

Know where your main shut-off valve is located! Clean clogged or slow drains. You should drain and flush the water heater periodically.

### Heating/Cooling System:

Check to make sure all outside equipment is not blocked by landscaping or debris. Its always good have an annual preventive maintenance check up with a qualified HVAC mechanic, it will be well worth it.

During these hours, please remember to keep these noise levels low. Noise ordinance violations should be reported to the Montgomery County police non-emergency number at 301-279-8000.


### **Architectural Control**
