IV. MANAGEMENT REPORT

A. Entrance Monument Landscape Proposals

Several Board members, and Jason Lines with PGC landscapes met on site on June 18th to review the landscaping at Palmetto Circle and Ranworth Drive entrance monuments. The Board reviewed the proposal for the Ranworth entrance and the Palmetto Circle entrance and turf renovation proposal.

The Board discussed adding plants that are drought tolerant.

Action: To Table the entrance monument landscape proposals.

Action: Management will get updated entrance monument landscape proposals that separate the turf renovation and forward them to the Board.

Action: Management will go out to bid for the landscaper for 2026, as the current landscape contract will be complete.

B. Common Area Dead Tree Removal

Several dead trees were observed during the common area inspections. Management obtained proposals from S&P Tree Care and PGC Landscapes for the removal of the trees. The Board discussed increasing the tree maintenance budget line item in the 2025 budget.

Motion: To approve the tree removal proposal from S&P Tree Care (dead Cherry on Palmetto, dead Cherry on Marksburg, dead Leaning Ash on Marksburg, two (2) dead Dogwoods on Marksburg and the dead White Pine on Marksburg) for the cost of \$3,750.00 as presented.

Barney/DiNardo Vote: Unanimous

C. 2025 Operating Budget

Management presented the 2025 budget which proposes a 3.9% increase for the General Budget (\$159.00 per quarter) and a 1% increase for the Townhouse Budget (\$256.00 per quarter), which includes an increase in the tree maintenance line item from \$11,430.00 to \$15,000.00.

Motion: To approve 2025 draft budget, which proposes a 3.9% increase for the General Budget (\$159.00 per quarter) and a 1% increase for the Townhouse Budget (\$256.00 per quarter) to be sent to homeowners for comment.

Barney/DiNardo Vote: Unanimous

D. Reserve Investments

Management and the Board reviewed the account record and discussed investing in some General Reserve and Townhouse Reserve CDs.

Motion: To invest \$20,000.00 from the General Reserve Money Market into a five (5) year General Reserve CD.

Motion: To invest \$50,000.00 from the Townhouse Reserve Money Market CD to mature in 2027.

Barney/ DiNardo Vote: Unanimous
