#### **B.** Steeple Road Stormwater Easement

Management explained that Montgomery County Department of Environmental Protection is performing a retrofit project for the Manchester Farm's asset #11226 stormwater facility located along Steeple Rd. The scope of the work will require removing some trees on both sides of Steeple Rd., due to MDE (Maryland Department of Environment) dam requirements with constructed dam embankments. There will be structural repairs to the principal spillway pipe under Steeple Rd. to include the downstream dam embankment and outfall area located on Kingsview Ridge common area. DEP needs SWM Easement granted so they can perform this dam maintenance.

Motion: To grant the Storm Water Management Easement and Right of Way between Kingsview Ridge Homeowners Association, Inc, and Montgomery County, MD as presented.
